ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 2ND JANUARY, 1932.)

BIRKENHEAD IMPORTED ANIMALS
WHARF AND LANDING PLACE ORDER,
1932.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

Definition of Imported Animals Wharf.

1. Such part of the premises described in the First Schedule hereto as is not for the time being the subject of a notice to be posted up thereon in manner provided by Article 2 hereof, is hereby defined as an Imported Animals Wharf for the purposes of the Diseases of Animals Acts, 1894 to 1927, and any Order of the Minister thereunder.

Approval of Landing Place for Canadian Store Cattle and for Animals from Ireland and the Isle of Man.

2. The premises described in the Schedules hereto are hereby approved by the Minister for use as landing places for the purposes of the Animals (Landing from Ireland, Channel Islands and Isle of Man) Order of 1923, and the Importation of Canadian Cattle Order of 1923, during such period or periods only as may from time to time be prescribed, in relation to the premises comprised in any one or more of the said Schedules, by a notice signed by a duly authorised Officer of the Ministry of Agriculture and Fisheries and posted up on some prominent position on the premises to which the notice relates.

Revocation.

3. The Birkenhead Imported Animals Wharf Order of 1930, and the Birkenhead Imported Animals Wharf Order of 1931, are hereby revoked.

Commencement.

4. This Order shall come into operation on the fourth day of January, nineteen hundred and thirty-two.

Short Title.

5. This Order may be cited as the BIRKENHEAD IMPORTED ANIMALS WHARF AND LANDING PLACE ORDER OF 1932.
