inafter mentioned should be heard and determined by a Committee appointed by the Lords Commissioners of Our Treasury and presided over by Our Trusty and Well-beloved Sir Harold Spencer Morris, Knight, one of Our Counsel learned in the Law, and that like claims by other persons made at any time after the said date should be heard and determined by Our High Court under and in accordance with Section 29 of the Patents and Designs Acts, 1907-1928.

Now, therefore, we do by these Presents hereby authorise order and require you the said Thomas James Chesshyre, Baron Tomlin (Chairman); Sir Gerald Edward Chadwyck-Healey; Sir George Lewis Barstow; Sir Cecil Edwin Fitch; Lionel Henry Hanbury; Alfred Chaston Chapman; William Ernest Dalby; Adolph Max Langdon and Percy Tindal-Robertson to proceed in due course to hear and determine such further claims within the terms of Our said Royal Commissions of the 19th day of March, 1919, and the 5th day of October, 1920, as may be notified to you on or before the 31st day of March, 1932, but not further or otherwise; and that so soon as you shall have heard and determined all such claims so notified to you, you do with all convenient speed report your proceedings under this Our Commission.

Tomlinson, 6, High Street, Belper, near Derby, subject to the conditions that, subject to any arrangements that may be made to meet the convenience of individual workers, a worker shall not be employed in the afternoon shift in consecutive weeks; that suitable accommodation for clothing put off during working hours, messroom accommodation and washing facilities shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.
