The Patent Office.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of each of the Benefices (all in the County of Lancaster and in the Diocese of Manchester) the names whereof are stated in the first column of the Schedule hereto, and to his successors Incumbents of the same Benefice, the yearly sum being the interest or dividends arising in respect of a sum of Local Loans three pounds per centum Stock, the amount of which is stated in the second column of the Schedule opposite to the name of the Benefice, or in respect of other the investments for the time being representing the same, such yearly sum to be payable out of the Common Fund under our control, and to be calculated as from the eighteenth day of December in the year one thousand nine hundred and thirty-one: Provided always that such yearly sum or any portion thereof shall be payable only upon the production to us, from time to time, of a certificate (in such form as may be required by us) under the hand of the Bishop of the Diocese certifying that during the period then ended, an Assistant Curate has been employed within the Parish of the Benefice, and duly licensed by such Bishop, and that such Assistant Curate has been in receipt of a stipend after a rate of not less than the amount of the yearly sum hereby granted. Provided also that the yearly sum so granted shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the Parish and Benefice in favour of which it is granted: Provided further that each yearly sum hereby granted shall be and shall be taken to be in lieu of and in full substitution for an equal sum being the whole or part of the yearly sum which was secured for the endowment of the same Benefice under the authority of another Instrument which was sealed by us on the twenty-eighth day of January in the year one thousand nine hundred and thirty-two and published in the London Gazette on the fifth day of February, in the same year but which was intended to be secured upon the conditions above mentioned.

URBAN DISTRICT OF HOLLINGWORTH.

PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the fourth day of February, 1932, the Minister of Health has declared that, on and after the twenty-ninth day of February, 1932, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Urban District of Hollingworth, namely:—

Part II (streets and buildings) other than sections 21, 24, 25, 27 and 31;

Part III (Sanitary provisions) other than section 51;

Part IV (infectious diseases) other than sections 61 and 68; and

Section 95 comprised in Part X (miscellaneous provisions).

The above provisions are declared to be in force subject, as regards Sections 23, 30, 35 and 38, to the conditions specified in the Order.
