

to us shall seem expedient and that the net proceeds of such sale shall be held and invested by us the said Ecclesiastical Commissioners as to one moiety thereof for the benefit of the United Benefice of Haresfield with Harescombe and as to the other moiety thereof for the benefit of the United Benefice of The Edge with Pitchcombe.

"5. That after the union referred to in Clause 1 of this Scheme has taken effect the course and succession in which the respective Patrons shall present or nominate to the United Benefice of Haresfield with Harescombe from time to time as the same shall become vacant shall be as follows, that is to say, that in every series of three successive turns of presentation or nomination to be made to the United Benefice of Haresfield with Harescombe after the union the Patron of the said Benefice of Haresfield shall have the first and the third turns and the Patron of the said United Benefice of Harescombe with Pitchcombe shall have the second turn.

"6. That upon the unions taking effect (a) a part of the endowments of the said United Benefice of Harescombe with Pitchcombe, namely, all those Tithe Rent Charges payable to the Incumbent of such United Benefice arising within the Parish of Harescombe and originally commuted at £89 10s. 11d. together with all capital sums of money, stocks, securities and other property being or representing the proceeds of any sale redemption or other conversion of the whole or any part of such Tithe Rent Charges and together also with a sum of £1473 10s. 4d. Local Loans £3 per cent. per annum Stock at present held by us, the said Ecclesiastical Commissioners, on behalf of the same United Benefice shall be transferred and annexed to the United Benefice of Haresfield with Harescombe and (b) all other the endowments of the said United Benefice of Harescombe with Pitchcombe shall be transferred and annexed to the United Benefice of The Edge with Pitchcombe.

"7. That with the consent of the Patrons of the said Benefice of Brookthorpe with Whaddon, namely, the Dean and Chapter of the Cathedral Church of the Holy and Indivisible Trinity at Gloucester (which consent is testified by their causing their Common or Capitular Seal to be affixed to this Scheme), and Lieutenant-Colonel Sir Audley Dallas Neeld, Baronet, C.B., M.V.O. (which consent is testified by his signing this Scheme), and with the consents of the said George Montagu Garner, and of the Reverend Andrew James Freeman, now Incumbent of the said Benefice of Standish with Hardwicke and the Reverend David Hedog-Jones, now Incumbent of the said Benefice of Brookthorpe with Whaddon (all which consents are testified by their respectively signing this Scheme), upon the said unions taking effect—

"(a) all that portion of the said Parish of Standish with Hardwicke comprising Colethrop Farm, Pool Farm, The Lessoms, Saint Mary Magdalene's Chapel, Colethrop, Pound Farm and Colethrop Court (which said portion is more particularly delineated and set forth upon the Map or Plan hereto annexed and thereon coloured green) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Haresfield;

"(b) all that further portion of the said Parish of Standish with Hardwicke comprising Hayes Farm (which said portion is more particularly delineated and set forth upon the said Map or Plan and thereon coloured blue) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Harescombe;

"(c) all that portion of the said Parish of The Edge comprising Gravel Court (which said portion is more particularly delineated and set forth upon the said Map or Plan and thereon coloured yellow) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Harescombe;

"(d) all that further portion of the said Parish of The Edge comprising Harescombe Grange and Lodge (which said portion is more particularly delineated and set forth upon the said Map or Plan and thereon coloured brown) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Harescombe;

"(e) all that portion of the said Parish of Harescombe comprising Fisher's Cottage and Sampson's Cottage (which said portion is more particularly delineated and set forth upon the said Map or Plan and thereon coloured pink) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of The Edge;

"(f) all those detachments and portions of the said Parish of Harescombe (other than the portion comprising Fisher's Cottage and Sampson's Cottage hereinbefore mentioned) which lie upon the side remote from Harescombe Village of an imaginary line commencing at the point where the boundary which divides the said Parish of Standish with Hardwicke from the said Parish of Harescombe crosses the middle of the road leading from Colethrop to Badge Green and extending thence first north-eastward, then northward, then again north-eastward past Daniel's Brook Cottages, along the middle of the said road to Badge Green, and extending then south-eastward along the middle of the road leading from Badge Green, past Styles Farm and Spring Farm to the road leading from Gloucester to Stroud and extending thence southward along the middle of the last mentioned road for a distance of eight chains and a half or thereabouts to the existing boundary of the said Parish of The Edge (the course of which said imaginary line is indicated by a red line upon the said Map of Plan) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Brookthorpe;

"(g) all those detachments and portions of the Parishes of Brookthorpe and Whaddon which lie upon the side nearer to Harescombe Village of the imaginary line hereinbefore described shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Harescombe;

"(h) all that extreme south-eastern portion of the said Parish of Haresfield containing approximately 35 acres and lying to the north-east of Standish Wood (which said portion is more particularly delineated and set forth upon the said Map or Plan and thereon coloured purple) shall be transferred and annexed for all ecclesiastical purposes to the said Parish of Pitchcombe; and
