And whereas the said Scheme has been laid before both Houses of Parliament for the space of two calendar months:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared, and laid before His Majesty in Council, a Scheme or Representation, bearing date the 18th day of February, 1932, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Saint Aidan, West Hartlepool, in the County of Durham and in the Diocese of Durham:

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the 20th day of March, 1891, and published in the London Gazette on the 24th day of the same month, a consolidated Chapelry was assigned to the consecrated Church of Saint Aidan, West Hartlepool, situate in the Parish of Stranton, in the said County and Diocese, and the said Consolidated Chapelry was named 'The Consolidated Chapelry of Saint Aidan, West Hartlepool':

"And whereas the said Consolidated Chapelry of Saint Aidan, West Hartlepool, has under the provisions of the Act of the

19th and 20th years of Her said late Majesty, Chapter 104, become a New Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94:

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Parish of Saint Aidan, West Hartlepool, should be altered in the manner hereinafter mentioned:

"Now, therefore, with the consent of the Right Reverend Herbert Hensley, Bishop of Durham (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Saint Aidan, West Hartlepool, shall be altered so that all that portion of the said Parish of Stranton which is described in the Schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink shall be dissevered from such Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Aidan, West Hartlepool.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the New Parish of Saint Aidan, West Hartlepool, in the County of Durham and in the Diocese of Durham, being:—

"All that portion of the Parish of Stranton, in the said County and Diocese, which is bounded upon the south east and upon the east by the said New Parish of Saint Aidan, West Hartlepool, and upon the remaining sides, that is to say, upon the north and upon the west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Aidan, West-Hartlepool, from the said Parish of Stranton at the junction of Stockton Road and Cornwall Street, and extending thence westward along the middle of Cornwall Street for a distance of 19 chains or thereabouts to its junction with Rugby Street, and extending thence southward along the middle of Rugby Street for a distance of 5% chains or thereabouts to its junction with Oxford Road, and extending thence eastward along the middle of Oxford Road for a distance of 16 yards or thereabouts to its junction with Caledonian Road, and extending thence southward along the middle of Caledonian Road for a distance of 27% chains or thereabouts to its junction with Stockton Road upon the boundary which divides the said Parish of Stranton from the said New Parish of Saint Aidan, West Hartlepool."
