South Eastern Counties Joint Vagrancy COMMITTEE.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Health, after the expiration of at least 40 days from this date, in exercise of the powers conferred upon him by Section 3 of the Poor Law Act, 1930, to make regulations for extending the present combination of the administrative counties of Kent, Southampton, Surrey, East Sussex and West Sussex, and the county boroughs of Bournemouth, Brighton, Canterbury, Croydon, Eastbourne, Hastings, and Southampton (made by the South Eastern Counties Joint Vagrancy Committee Order, 1931) so as to include the county borough of Portsmouth, for the purpose of the better administration of the relief of casual poor persons within the combined areas:
