WELLS.

Whereas the Mayor Aldermen and Citizens of the City of Wells (hereinafter called the Corporation) being the Urban Authority for the said City, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal alter or amend the Wells Corporation Water Act, 1901, so as:—

(1) To authorise the acquisition by the Corporation and the holding by them for the purposes of their water undertaking of lands in the out parish of St. Cuthbert in the rural district of Wells, comprising

(a) an area of 25 acres 2 roods and 4 perches or thereabouts situate on the west side of and adjoining the road at Upper Milton leading from there to Rookham and Priddy, of which area a portion comprises Vigo Wood;

(b) land being the site of Estate reservoir forming part of the land situate on the west side of and adjoining the road at Upper Milton leading from there to Rookham and Priddy and on the south side of road known as Tynings Lane;

(c) land being the site of the reservoir or tank and spring of water now supplying water to Ebbor Farm and situate between Hope Wood and Ebbor Wood;

all of which lands are shown coloured pink on a map which is deposited at the Town Clerk's Office, 1, Cathedral Green, Wells, and may be inspected there during ordinary office hours by any person interested; together with the right to take and use for the purpose of their undertaking all such springs and waters as may be found in on or under the lands above specified;

(2) To empower the Corporation, with the consent of the Minister of Health, by agreement to purchase take on lease acquire and hold such further lands as they may require from time to time for the purposes of their water undertaking;

(3) For the several purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act

or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said city as may be necessary or desirable;
