AT QUEEN'S ROAD, HENDON.

Six Hackney Carriages:

Six carriages to stand on South side of roadway, commencing opposite public street lamp No. 287 on railway bridge, extending Eastward, by kerb, as far as necessary for six carriages.

Front of vehicles toward the West.

AT RUSSELL SQUARE, W.C.
(NORTH AND WEST SIDES).*In two portions.*

Twenty Hackney Carriages:

First Portion. Ten carriages on the North side of Russell Square, commencing at a point in line with the Western building line of Upper Bedford Place, and extending Westward, by kerb around the garden enclosure, as far as necessary for ten carriages.

Front of vehicles toward the East.

Second Portion. Ten carriages on the West side of Russell Square, commencing at a point opposite the party wall between Nos. 31 and 32, and extending Southward, by kerb around the garden enclosure, as far as necessary for ten carriages.

Front of vehicles toward the North.

The first portion of the Standing to be fed exclusively by carriages from the second portion.

NOTE.—The second portion may be reserved for not exceeding ten carriages whilst the drivers are according to the Regulations, at meals.

AT MANOR GARDENS, CHELSEA.

Two Hackney Carriages:

Two carriages to stand on North side of roadway, commencing at a point fifteen feet West of the Western building line of Manor Street, extending Westward, by kerb, as far as necessary for two carriages.

Front of vehicles toward the East.

NOTE.—The gateway leading to the Public Baths to be kept clear.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.

The Secretary of State has made an Order dated 23rd March, 1932, under Section 7 of the Reorganisation of Offices (Scotland) Act, 1928, providing for the discontinuance as from 1st April, 1932, of the office of Director of Chancery.

The Order, which has been made after consultation with the Lord President of the Court of Session, directs that the powers and duties of the Director with respect to bonds of caution for tutors of law, curators, and tutors-dative, and the issue of letters of tutory or curatory

under the Judicial Factors Act, 1849, and to the procedure for the cognition of the insane under the Court of Session Act, 1868, shall be exercised and performed by the Principal Extractor of the Court of Session; and that all the other powers and duties of the Director shall be exercised and performed by the Keeper of the Registers and Records of Scotland.
