### CHAPTER V.

Of the Educational Staff and College Officers.

By adding to the second paragraph of Section 4 of this Chapter after the word "Lecturer" the words "Director of Studies".

By deleting from Section 14 of this Chapter the words "Fellows appointed in turn from the" and adding at the end of the Section the following paragraph:—

"The Society in College Meeting shall from time to time make arrangement for the fulfilling of the duty of residence under this Section."

#### APPENDIX III.—SUPERANNUATION SCHEME.

By deleting from Section 7 of this Appendix the words "If, however, a Member entering the Scheme... of the Federated Superannuation System." and substituting therefor the following words:—"If, however, a Member entering the Scheme comes from a University or College within the British Empire outside the British Isles, holding a policy or policies, which has or have been entered into under a Pension Scheme in that University or College and approved by its Governing Body, such policy or policies may be recognized for the purposes of the Scheme, subject to the approval of the Institution to which he belongs and the Central Council of the Federated Superannuation System."

### EXCISE DUTY ON CERTAIN TEA.

- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
