ORDER OF THE MINISTER OF
AGRICULTURE AND FISHERIES.

(DATED 19TH APRIL, 1932.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:—

*Authorisation of Landing of Animals for
Exceptional Purposes.*

1. The landing of the animals described in the First and Third Schedules hereto are hereby allowed subject to the Provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and Part VI (Animals intended to be landed at an Imported Animals Quarantine Station) of the Animals (Importation) Order of 1930, hereinafter referred to as the "Principal" Order and of this Order.

Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the detention of the animal described in the First Schedule hereto and the premises described in the Fourth Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the detention of the animal described in the Third Schedule hereto.

*Regulations applicable to the animals before
and on Landing.*

3.—(1) Each animal before being landed, shall be examined by a Veterinary Inspector of the Ministry, and if found by him to be free from symptoms of disease, shall forthwith be landed and moved in a float, cart, van, or other suitable vehicle under the supervision of the Inspector from the place of landing to the Imported Animals Quarantine Station described in the Second or Fourth Schedule hereto as the case may be; the said vehicle shall be cleansed and disinfected before and after such use in the manner prescribed by the Inspector.

(2) Each animal shall be detained and isolated in the said Quarantine Station in accordance with the provisions of the Principal Order for a period of twenty-eight days after arrival thereat and during the movement from the quay to the said premises and during the said period of detention shall be kept separate from all other animals including canines and felines and no other ruminating animal or swine shall be moved into the premises described in the said Schedules. When moved from the

said Quarantine Station each animal shall be accompanied by the certificate and licence required by Article 40 (8) of the Principal Order.

In witness whereof the Official Seal of the Minister of Agriculture and Fisheries is hereunto affixed this nineteenth day of April, nineteen hundred and thirty-two.

FIRST SCHEDULE.

One goat, the Regimental Mascot of the 1st Battalion The Royal Welch Fusiliers, brought from Egypt to be landed in the Port of Southampton on or before the twenty-fifth day of April, nineteen hundred and thirty-two.

SECOND SCHEDULE.

Kennels and adjoining exercise yard numbered 81 and 82, and marked "H" respectively on the plan sealed by the Minister of Agriculture and Fisheries on the 10th September, 1931, in connection with the approval of the premises at Bitterne Manor Farm, Bitterne, in the County Borough of Southampton, for the purposes of the Importation of Dogs and Cats Order of 1928.

THIRD SCHEDULE.

One goat, the property of the 1st Battalion The Royal Welch Fusiliers, brought from Cyprus to be landed in the Port of Southampton on or before the twelfth day of May, nineteen hundred and thirty-two.

FOURTH SCHEDULE.

A space 42 ft. by 16 ft. surrounded on three sides by a 7 ft. wall, and on the other side by an iron railing fence containing four kennels, and the adjoining exercise yard. The said space is coloured green and adjoins the exercise yard marked "G" on the plan referred to in the Second Schedule.
