WHEREAS the Minister of Health, after giving to the Incumbent and Churchwardens of the Parish of Warmington, in the County of Northampton, 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to His Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Warmington, in the said County of Northampton, save with the previous approval of the Minister of Health, should be prohibited, and that, except as hereinafter provided, burials should be discontinued therein as follows, viz. :

WARMINGTON.—Forthwith and entirely in the Parish Church of Saint Mary the Virgin, in the said Parish, and in the Churchyard attached thereto.

(a) In the walled grave now existing in the said Churchyard and belonging or reputed to belong to Katherine Turnill, the burial may be allowed of the body of the said Katherine Turnill at her decease subject to the condition that the coffin buried in such grave be separately enclosed by stonework or brickwork properly cemented.

(b) In earthen graves now existing in the said Churchyard the burial may be allowed of the bodies of the following persons at their decease, viz. Elizabeth Kidd, Elizabeth Harbour, Fanny Peploe, Ellen Harriet Oakley, Louisa Howell, Rachael Burdett, Mary Ann Gilder, Sarah Lines, Fanny Bartlett, Sarah Annie Howell, and Eric Mildmay Turnill, subject to the condition that no part of the coffin containing the body shall in any case be at a depth less than three feet below the level of the surface of the ground adjoining the

Now, therefore, His Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy

Council on the 4th day of June next.
