THE CORONERS (AMENDMENT) ACT, 1926.

ORDER FOR THE ALTERATION OF CORONERS' DISTRICTS.

I, the Right Honourable Sir Herbert Samuel, one of His Majesty's Principal Secretaries of State, in pursuance of the powers vested in me by Section 12 of the Coroners (Amendment) Act, 1926, hereby order that the Parishes of Barton Bendish, Bexwell, Beechamwell, Crimpleham, Denver, West Dereham, Downham Market, Downham West, Fincham, Fordham, Hilgay, Holme next Runcton, Marham, Nordelph (part of), Roxham, South Runcton, Ryston, Shouldham, Shouldham Thorpe, Southery, Stoke Ferry, Stow Bardolph, Stradsett, Tottenhill, Wallington cum Thorpland, Watlington, West Welney, Wereham, Wimbotsham, Wormegay and Wretton (which said Parishes formed the Hundred of Clackclose and the Liberty of Sir Thomas Hare) and the Parishes of Nordelph (part of), Outwell, Upwell, and Welney (which said Parishes formed the Half Hundred of Clackhouse and the Liberty of Charles Watson Townley) shall be transferred to and merged in the Lynn District of the County.

This Order shall come into effect forthwith.

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an Order authorising the employment on two day-shifts, of women of 18 and young persons of 16 years of age and over in moulding, trimming, polishing and boxing soap boxes and cutting, drilling and profiling knife handles in the Sundries Department at the works of The British Xylonite Company Limited, Hale End, E.4, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks; that suitable cloakroom and messroom accommodation and washing facilities shall be provided; and that the Secretary of State may at any time require the occupiers to make such special arrangements for the conveyance of workers living at a distance or otherwise for the welfare of such workers as may be necessary to prevent hardship.

Driver, Hartley and Company Limited, Dalton Lane, Keighley, Yorkshire, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that suitable accommodation for clothing put off during working hours, messroom accommodation and washing facilities shall be provided.

James Keiller and Son Limited, Tay Wharf, Factory Road, Silvertown, E.16, subject to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks, and that suitable protective clothing, cloakroom and messroom accommodation and washing facilities shall be provided.
