WELFARE OF WORKERS IN FACTORIES AND WORKSHOPS.

The Secretary of State for the Home Department hereby gives notice that, in pursuance of the powers conferred on him by Section 7 of the Police, Factories, etc. (Miscellaneous Provisions) Act, 1916, of making Orders for securing the welfare of the workers employed in factories and workshops, he proposes to make an Order to apply to factories and workshops or parts thereof in which clay, sand, lime, or similar materials are made into bricks, tiles, blocks, slabs, pipes, nozzles, or similar articles.

Where an objection is made jointly on behalf of a number of occupiers, the names of the occupiers and their addresses must be stated, or, if the objection is made by an association of occupiers on behalf of its members, the number of the members affected by the Order.
