FOREIGN HAY AND STRAW (AMEND-MENT) ORDER OF 1932 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1927, and of every other power enabling him in this behalf, hereby orders as follows:-

Prohibition of Landing of Hay and Straw from State of California.

1. Hay and Straw brought from the State of California in the United States of America shall be subject to the prohibition of landing
