DENUNCIATION OF THE ANGLO-NORWEGIAN AGREEMENT RELATING TO THE RELIEF OF DISTRESSED SEAMEN, SIGNED JULY 12TH, 1881.

His Majesty's Principal Secretary of State for Foreign Affairs has received from the Norwegian Minister in London a communication dated November 30th, 1931, giving notice of denunciation by the Norwegian Government, as from January 1st, 1932, of the Anglo-Norwegian Agreement relating to the Relief of Distressed Seamen, signed at London on July 12th, 1881, which provides for the termination of the Agreement on the expiration of one year's notice by one of the contracting parties.

The Agreement will accordingly terminate on January 1st, 1933.

Upon the termination of this Agreement the notes exchanged between November 28th, 1907, and May 4th, 1908, regarding the interpretation of the expression "third state" in the Agreement will become automatically terminated.

FACTORY AND WORKSHOP ACTS, 1901 to 1929.
