Provided that-

- (a) In the walled grave now existing in the said Churchyard and belonging or reputed to belong to Katherine Turnill, the burial may be allowed of the body of the said Katherine Turnill at her decease subject to the condition that the coffin buried in such grave be separately enclosed by stonework or brickwork properly cemented.
- (b) In earthen graves now existing in the said Churchyard the burial may be allowed of the bodies of the following persons at their decease, viz., Elizabeth Kidd, Elizabeth Harbour, Fanny Peploe, Ellen Harriet Oakley, Louisa Howell, Rachael Burdett, Mary Ann Gilder, Sarah Lines, Fanny Bartlett, Sarah Annie Howell, and Eric Mildmay Turnill, subject to the condition that no part of the coffin containing the body shall in any case be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

#### UNIVERSITY OF OXFORD.

STATUTE APPROVED BY CONGREGATION ON TUESDAY, 7TH JUNE, 1932.

WHEREAS it is expedient, as a consequence of the constitution of a Faculty of Social Studies, to make amendments in Title V of the Statutes of the University of Oxford, NOW THE SAID UNIVERSITY in exercise of the powers in that behalf conferred upon it by the Universities of Oxford and Cambridge Act, 1923, and of all the powers enabling it, ENACTS, SUBJECT TO THE APPROVAL OF HIS MAJESTY IN COUNCIL, AS FOLLOWS.

to the Board of the Faculty of Social Studies the subject of which falls within the province of the Board of the Faculty of Literae Humaniores".
