

At the Court at *Buckingham Palace*, the 21st day of *July*, 1932.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 2nd day of *July*, 1932 (N. 2221/32), in the words following, viz. :—

“Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

“And whereas we consider it desirable that extra pay should be granted to ratings of the Writer and Supply branches employed on cypher work when local conditions are such that this work involves an appreciable amount of extra work in addition to ordinary duties:

“We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the grant of extra pay of one shilling a day to Chief Petty Officers and Petty Officers of the Writer and Supply branches who are qualified in cypher duties and who are employed regularly in peace time on these duties in sloops and similar vessels on detached service on foreign stations, when not more than one Accountant Officer is borne, payment to be confined to the days on which the ratings actually perform cyphering duties which entail a considerable amount of work outside their normal working hours.

“The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal.”

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

WHEREAS by Section 13 of the Air Force (Constitution) Act, 1917, it is provided that His Majesty may, by Order in Council, apply, with the necessary modifications and adaptations, in relation to the Air Council, the President of the Air Council, and the Air Force, and the officers and men thereof, and air force property or institutions, any of the enactments relating to the Army Council, the Secretary of State for the War Department, the Army, or the officers and soldiers thereof

(including enactments conferring any powers, rights, exemptions or abatement from taxation or immunities, or imposing any duties or disabilities on such officers or soldiers), or to military property or institutions:

And whereas by various Orders made under the said Section certain enactments have been applied in relation as aforesaid, and it is expedient so to apply a certain further enactment contained in the Superannuation Act, 1887, being the enactment mentioned in the first column of the Schedule to this Order:

And whereas the provisions of Section 1 of the Rules Publication Act, 1893, have been complied with:

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, as follows:—

1. The enactment mentioned in the first column of the Schedule to this Order, being an enactment relating to the officers and men of the Army, shall apply in relation to the officers and men of the Air Force, subject to the adaptation specified in the second column of that Schedule.

2. This Order may be cited as “The Air Force (Application of Enactments) Order, 1932.”

WHEREAS the Lord Chancellor has represented that it is expedient to vary the County Courts (Admiralty Jurisdiction) Order in Council, 1899, so as to extend the district of the Mayor's and City of London Court for Admiralty purposes:

Now, therefore, His Majesty, in exercise of the powers in that behalf by the County Courts Admiralty Jurisdiction Act, 1868, or otherwise in His Majesty vested, having taken the said representation into consideration, is pleased by and with the advice of His Privy Council, to order and appoint, and it is hereby ordered and appointed, as follows:—

1. There shall be assigned to the Mayor's and City of London Court as its district for Admiralty purposes the districts of the County Courts mentioned in the Schedule to this Order.

2. This Order may be cited as the County Courts (Mayor's and City of London Court) Admiralty Jurisdiction Order, 1932, and the
