I, the undersigned, Commissioner of Police of the Metropolis, do hereby APPOINT Standings for Hackney Carriages at the following places, and do make the following Regulations with regard to the Boundaries for the same, viz.:—

APPOINTMENTS.

AT ST. JOHN'S ROAD AND BOOTHBY ROAD, UPPER HOLLOWAY.

Thirteen Hackney Carriages:

First Portion—At St. John's Road, in centre of roadway, eight carriages to stand, commencing at a point in line with the electric lamp standard outside St. John's Road Wesleyan Church, and extending North-eastward as far as necessary for eight carriages.

Front of vehicles toward the South-west.

Second Portion—At Boothby Road, on West side of roadway, three carriages to stand, commencing at a point sixteen feet South of the Southern building line of St. John's Road, extending Southward, by kerb, as far as necessary for three carriages.

Front of vehicles toward the North.

Third Portion.—At Boothby Road, on West side of roadway, two carriages to stand, commencing at a point opposite the doorway of No. 9, Boothby Road, extending Southward, by kerb, as far as necessary for two carriages.

Front of vehicles toward the North.

The first portion of the Standing to be fed exclusively by carriages from the second portion, and the second portion from the third portion.

Note.—The third portion may be reserved for two carriages whilst the drivers are, according to the Regulations, at meals.
