Order of Your Majesty in Council affirming this Scheme or such extended period as we, the said Ecclesiastical Commissioners, with the concurrence expressed in writing of the Bishop of London, may approve, the said Herbert James Salmon with the approval of the Bishop of London and the Ecclesiastical Commissioners shall by institution to another Benefice vacate the said Benefice of Curtain Road, Saint James, in order that the said union may thereupon take effect, there shall be paid to him by way of compensation out of the aggregate fund referred to in the original Order a capital sum of £50 and there shall be reserved in our hands out of the same fund a capital sum sufficient in our opinion to raise his income as Incumbent of any Benefice to which he is so instituted to the annual amount of £510 if the income of such Benefice shall be less than that annual amount and the income from the said capital sum so reserved shall be payable to him for so long as he shall continue to hold that Benefice and after the cessation of such payment the capital sum shall fall into the residue of the said aggregate fund, and we the said Ecclesiastical Commissioners shall be at liberty to advance such capital sums as provided in the original Order.

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Union of Benefices Measure, 1923, or of any other Measure of the National Assembly of the Church of England or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners within the time prescribed in the same Rules:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of London has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with
the advice of His said Council, is pleased hereby to affirm the said Scheme and to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar

of the said Diocese of London.

TENDERS FOR TREASURY BILLS.

- 1.
