AT KNIGHTSBRIDGE, S.W.

Twenty-three Hackney Carriages:

*First Portion.*—Three carriages to stand in centre of roadway, commencing immediately West of the refuge opposite St. George's Hospital, extending Westward as far as necessary for three carriages.

Front of vehicles toward the East.

*Second Portion.*—Twenty carriages to stand on North side of roadway, commencing at a point twenty yards West of the Water trough, extending Westward, by kerb, as far as necessary for twenty carriages.

Front of vehicles toward the East.

The first portion of the Standing to be fed exclusively by carriages from the second portion.

AT Highbury Place and  
Highbury Crescent.

Seventeen Hackney Carriages:

*First Portion.*—One carriage at Highbury Place on South-east side of roadway, to stand at a point two yards North-east of the sand-bin.

Front of vehicle toward the South-west.

*Second Portion.*—Sixteen carriages at Highbury Crescent, on North side of roadway, commencing at a point nine yards North of the junction with Highbury Place, extending Northward, by kerb, as far as necessary for sixteen carriages.

Front of vehicles toward the South.

The first portion of the Standing to be fed exclusively by carriages from the second portion.

NOTE.—During the period when meetings are being held in Highbury Crescent the second portion of the Standing will be transferred to Highbury Place, North-west side of roadway, and commence nine yards North-east of the junction with Highbury Crescent, carriages to face South-west.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
