(ii) any vehicle which is being used in connection with the maintenance, improvement or reconstruction of the said roads or the laying, alteration or repair in or near to the said roads of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity, or any telegraph or telephone wires, cables, posts or supports.
