12 inches in both length and breadth, with longitudinal slots exceeding 2 inches in width and 4 inches in depth as are not entered under the Customs Acts before the seventh day of September, 1932, or which have not been removed from a bonded warehouse before that date, shall be exempt from the duty imposed by Section one of the Safeguarding of Industries Act, 1921, as amended by the Finance Act, 1926, for a period ending on the 31st day of December, 1933.

2. This Order may be cited as the Safe-

guarding of Industries (Exemption) No. 1
