

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Route No. 603) Provisional Regulations, 1932, to come into operation forthwith as Provisional Regulations to continue in force until Regulations have been made in accordance with the provisions of Section 1 of that Act.

These Regulations provide for the operation of a service of omnibuses on Route No. 603 (Winchmore Hill (Chase Side Tavern) and Muswell Hill Broadway).

#### LONDON TRAFFIC ACT, 1924.

##### SECTION 7.

Notice is hereby given that the Minister of Transport, by virtue and in exercise of the powers given to him by Section 7 of the London Traffic Act, 1924, and the Regulations from time to time made by him thereunder, after consulting the London and Home Counties Traffic Advisory Committee, has relaxed the restrictions and limitations imposed by the said Regulations upon the occasion of the Elstree and District Horticultural Society Show to be held at Aldenham on Saturday, the 3rd day of September, 1932, so that nothing in the said Regulations shall prevent any person who is maintaining at the date of this notice a regular service in accordance with Section 6 of the London Traffic Act, 1924, upon the approved route numbered 311C from making on that day after 12 noon in any of the streets or parts thereof between Bushey and Boreham Wood declared to be "restricted streets" by any Order made by the Minister of Transport under the aforesaid Section 7 of the London Traffic Act, 1924, and forming part of that approved route, nine journeys in each direction with his omnibuses plying for hire on that approved route in excess of the number of journeys which he may so make in those streets or parts thereof under the said Regulations; provided that nothing herein contained shall be deemed to affect or derogate from the powers of the Commissioner of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give directions to constables for keeping order and for preventing any obstruction of the thoroughfares.

##### LAND DRAINAGE ACT, 1930.

##### *River Wye Catchment Area.*

Notice is hereby given that the Minister of Agriculture and Fisheries, in exercise of the powers conferred upon him under Section 4 (3) of the Land Drainage Act, 1930, proposes to make an Order confirming a scheme submitted to him by the River Wye Catchment Board under Section 4 (1) (a) of the Act, for the transfer to the Catchment Board of all rights, powers, duties, obligations and liabilities over or in connection with the main river as were immediately before the commencement of the said Act vested in or to be discharged by any drainage authority, and of any property held by the authority for the purpose of, or in connection with, any functions so transferred.

#### LAND DRAINAGE ACT, 1930.

##### NOTICE OF THE MAKING OF AN ORDER BY THE MINISTER OF AGRICULTURE AND FISHERIES.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming the River Cuckmere Catchment Board (transfer of powers of the River Cuckmere Drainage Board) Order, 1932, made under Section 11 of the Act.
