LLANGYNWYD MIDDLE ELECTRICITY.

NOTICE is hereby given that the South Wales Electric Power Company whose principal office is situate at Broad Sanctuary Chambers, 11, Tothill Street, in the County of London (hereinafter called "the Company") have applied to the Electricity Commissioners under the Electricity (Supply) Acts 1882 to 1928 for a Special Order (hereinafter called "the Order") for all or some of the following amongst other purposes (that is to say):—
