LOCAL GOVERNMENT ACT, 1888.

Proposed alterations of the County Boundary between the Administrative Counties of the Isle of Ely and Norfolk.

NOTICE is hereby given that the County Councils of the Administrative County of the Isle of Ely and of the County of Norfolk, have presented a joint Memorial under their respective Common Seals to the Minister of Health under Section 54 of the Local Government Act, 1888, praying that he will make an Order to carry out, and cause to be introduced into Parliament a Bill to confirm such Order, the following alterations of the County Boundary, namely:—

1. The use of the centre of the River Nene as the County Boundary in the parishes of Tydd St. Giles, West Walton, and Walsoken, from the point where the northern boundary of the Isle of Ely and Holland County at Tydd St. Giles crosses the River Nene, southwards along the centre of the River Nene to the existing northern boundary of the Borough of Wisbech.

2. The transfer to the Borough of Wisbech of a part of the parish of Walsoken east of the Borough. The new County and Borough boundary would leave the existing boundary at New Common Bridge and proceed along the east side of Ramnoth Road to the existing Walsoken Urban District Boundary, and thence eastwards along this boundary to a point almost due south of Manor House Road Crossing, thence northwards along Sandy Lane and Chapnall Field to Walsoken Church wall, circumventing the church, church-yard, and cemetery, in a westerly direction, thence northwards across Black Bear Lane, to the centre of Leaherd's Field, thence westwards across the Wisbech-King's Lynn and Wisbech-West Walton Roads, along the south side of Letaff's Field across the Roman Bank to the present Wisbech Borough Boundary.

3. The use of the centre of the Wisbech Canal as the County Boundary in the parishes of Wisbech St. Peter, Emneth, Elm, and Outwell, from New Common Bridge to the south side of Outwell Basin.
