

LOCAL GOVERNMENT ACTS,  
1888 AND 1894.

COUNTIES OF LANCASHIRE AND CHESHIRE.

Whereas in pursuance of Section 54 of the Local Government Act, 1888, representations have been made to the Minister of Health by the Councils of the Counties of Lancashire and Cheshire that it is desirable that the boundaries of the Counties should be altered by Provisional Orders under the Act so as to include therein part of the Urban District and parts of the Parishes indicated in the Schedule below.

And whereas a Provisional Order for the alteration of the boundary of a County may deal with any of the matters mentioned in Sections 54 and 59 of the Local Government Act, 1888, and Section 54 of the Local Government Act, 1894, and may also amend any Local and Personal Act or repeal, alter or amend any Provisional Order made under the Public Health Act, 1875, or made under the Sanitary Acts, and it is proposed that if Provisional Orders should be made upon the representations recited above the Orders should provide for the matters aforesaid.

Notice is hereby given that G. H. Thisleton-Dyer, Esquire, M.Inst.C.E., one of the inspectors of the Minister of Health, will attend at the Town Hall, Warrington, on Wednesday, the fifth day of October, 1932, at 11 o'clock in the forenoon, to hold a Local Inquiry into the representation of the Councils of the Counties of Lancashire and Cheshire and into any valid objection which may be received before the twenty-second day of September, 1932, and whether Provisional Orders should be made by the Minister for carrying into effect the proposals contained in the representations or such other proposals as he may deem expedient.

And notice is hereby further given that any person interested may attend at such inquiry and be heard with reference to the subject-matter of the Inquiry.

RULES PUBLICATION ACT, 1893.

ROAD TRAFFIC ACT, 1930.

And Notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the Public Service Vehicles (Conditions of Fitness) (Amendment) (No. 4) Provisional Regulations, 1932, to come into force forthwith as Provisional Regulations and to continue in force until Statutory Rules have been made in accordance with the provisions of Section 1 of that Act.
