

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty, Queen Victoria, Chapter one hundred and eleven, section five and of our Regulations established under the authority of the "Ecclesiastical Commissioners (Provision for Unbeneficed Clergy) Measure, 1928", and dated the 1st day of August, 1929, do hereby grant out of our Common Fund the yearly sums amounting in all to one thousand six hundred and eighty-five pounds set out in Reports or in the Schedules to Reports of our Estates Committee dated the eighth day of October, the nineteenth day of November, and the third day of December in the year one thousand nine hundred and thirty-one, and the twenty-first day of January, the eleventh day of February, the tenth day of March, the seventh and the twenty-first days of April, the second day of June, and the twenty-first and the twenty-eighth days of July in the year one thousand nine hundred and thirty-two, and adopted at our General Meetings of the fifteenth day of October, the twenty-sixth day of November, and the tenth day of December in the year one thousand nine hundred and thirty-one, and the twenty-eighth day of January, the eighteenth day of February, the seventeenth day of March, the fourteenth and the twenty-eighth days of April, the ninth day of June, the twenty-eighth day of July, and the thirteenth day of October in the year one thousand nine hundred and thirty-two respectively, each such yearly sum to be payable during our pleasure and subject to the conditions contained in the said Regulations and the special conditions (if any) set out in the said Reports or any of them to the unbeneficed clergyman indicated in the relevant Report or Schedule thereto, to commence from the date specified in such Report or Schedule and so long as it continues payable to be paid by equal quarterly payments on the first day of February, the first day of May, the first day of August and the first day of November in each and every year.
