Twelve Hackney Carriages:
On North side of roadway, commencing opposite the centre doorway of "Bricklayers Arms" Public House, extending Westward, by kerb, as far as necessary for twelve carriages.
Front of vehicles toward the East.

Provided that no Hackney Carriage shall be suffered to stand across any street or thoroughfare, or opposite the end of any street or carriage-way, or upon any place where foot passengers usually cross the carriage-way.
