PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

BY an Order dated the eleventh day of November, 1932, the Minister of Health has declared that, on and after the twenty-eighth day of November, 1932, the following provisions of the Public Health Acts Amendment Act, 1907, shall be in force in the Rural District of Guildford, namely:—

Section 15.—Deposit of plans to be of no effect after certain intervals.

Section 16.—As to plans deposited with the Local Authority.
