DRESSMAKING AND WOMEN'S LIGHT CLOTHING TRADE BOARD (ENGLAND AND WALES).

PROPOSAL TO VARY CERTAIN MINIMUM RATES OF WAGES.

In accordance with Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, and dated 21st April, 1927, the Dressmaking and Women's Light Clothing Trade Board (England and Wales) established under the Trade Boards Acts, 1909 and 1918, HEREBY GIVE NOTICE that they PROPOSE TO VARY Minimum Rates of Wages for certain classes of Male and Female Workers set out in their Notice W.D. (15) dated 3rd August, 1922, and in their Notices W.D. (18), W.D. (19) and W.D. (20), dated 28th April, 1923.

Full particulars of the proposed variations may be obtained on application to the Secretary of the Trade Board.

Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board WILL CONSIDER ANY OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 2nd of December, 1932. Such Objections should be in writing and signed by the person making same (adding his or her full name and address) and should be sent to the Secretary, Dressmaking and Women's Light Clothing Trade Board (England and Wales), 1, Whitehall Gardens, London, S.W.1. It is desirable that objections should state precisely and, so far as possible with reasons, what is objected to.
