Stockholme, April 20. N. S.

Yesterday the Duke of *Holstein* arrived here, having been conducted through the Kingdom with great Marks of Respect. The King of *Sueden* rid about 10 English Miles to meet him, and at some distance from the City he was received by the Senators in a Body. There the King left his Horse, and, together with the Duke, (to whom he gave the Hand) and the Prince his Brother, went into one of his Coaches, attended by the Coaches of the Senators, and other Persons of Quality, with 6 Horses each. Thus they proceeded to the Palace, where the Guns were fired, and discharges made by the Foot Guards and City Militia, that were drawn up on this Occasion. The Duke and the Prince his Brother Dined with the King, and in the afternoon his Highness visited the Queen Mother, the two Princesses, and the Dutchess Dowager his Mother. The Compliments upon the approaching Marriage have been given, and received on all sides with great Expressions of Satisfaction, and it is thought that Solemnity will not be long deterred. The Count *d'Arnaud*, Ambassador from *France*, has lately had an Audience of the King of *Sueden*, in which he delivered to him a Letter from the Most Christian King; and he has since been several times in Conference with the Ministers at this Court, upon some Proposals from that Crown. The Alliance between this Kingdom and the House of *Luxembourg* having been renewed by a Treaty made some time ago to that effect at *Hambourg*, the Ratifications of the same have lately been sent thither, in order to their being exchanged.

Warsaw, April 25. The Affairs of the General Dyet remain hitherto much in the same condition; at their first Meeting they chose their Maréchal or Speaker, and that's all they have yet done, the Protest made by the Deputies of *Lithuania* not suffering them to take any Resolution; All the Endeavours that have been used to persuade the said Deputies of *Lithuania* to return to their places in the Dyet, have hitherto been ineffectual, they still persisting in their refusal to be present at any other Dyet but such as shall be held in the manner they desire: However they have consented to stay here till the return of the Expresses that have been dispatched to the Palatinates which they represent, to endeavour to procure them new Instructions. Divers of the Gentry have made fresh Applications to the King of *Poland*, that he would send home all his German Forces; In answer to which he has declared, That it is not convenient to hasten their departure during the present posture of Affairs, but as soon as the Kingdom shall be restored to its former quiet, he will immediately send away his Troops. The Under-General of *Lithuania* arrived here yesterday, and his had Audience of the King; He is a Favourer of the *Sieur Oginsky*, and those that join with him, and endeavours to justify their Proceedings: At the same time we hear General *Sapich's* Party is considerably increased, and that he appears fully resolved to pursue his Revenge of the Injuries done him by the contrary Faction. Those of the Nobility of *Poland* who have a true Zeal for their Country, shew it on this Occasion, by endeavouring to put an end to the Divisions that are so prejudicial to its true Interest, and Prince *Radzivil* intends to go to the Meeting of the Gentlemen of the *Rokorz* appointed for the 5th of the next month at *Lowitz*, to try once more what may be done towards persuading them to submit to the King; and it is said some considerable Persons will shortly set out likewise for *Lithuania*, to Negotiate an Agreement between the two Contending Parties in that Dutchy. The Popes Nuncio's seem with much earnestness to second these good Intentions, and publicly declare against the holding of a Dyet on *Horseback*, as subject to great Inconveniencies at this time.

Vienna, April 30. The Popes Nuncio has lately received a considerable Sum of Money from *Rome*, with Orders to dispose of the same for the Service of the Emperor's Forces, as he shall be directed by this Court. Last Saturday the Emperor made several Knights of the *Golden-Fleece*, among whom were the Princes of *Eggenberg* and *Lichtenstein*, Count *Wurmen*, Count *Breiner*, and Count *Thun*. Recruits are daily passing by this place in their way to *Hungary*, and the preparations for the Fleet on the *Danube* are made with all possible expedition; 4 of the new built Gallies are already launched, as the remaining two will likewise be very suddenly, so that they will in a short time fall down the River to *Peter-Waradin*, which is appointed for the Rendezvous of the Vessels that are this Summer to be employed against the Turks. The Saxon Forces that served in *Hungary* being recalled by the King of *Poland*, are marching to that Kingdom, and will be followed by the Danes that are in the same Service, as soon as General *Tramp*, who is lately arrived here from *Denmark*, has adjusted with this Court some Matters relating to the Arrears due to the said Forces. We have advice from *Turkey*, that the Horse Tails were hung out at *Adrianople* on the 26th of *March*, being the usual Signal of the Grand Signior's intention to go to the War. Our Letters from *Hermanstadt* say, the Garison of *Belgrade* since the Reinforcement they lately received, is become 8000 Men strong; and that the Turks are repairing *Banzoua* and *Vyspalanka*, and intend to keep Garisons in those places; They add, that a strong Party of the Enemy which were come out from *Belgrade* to make an Incurion upon our Frontiers, had been obliged to return without effecting any thing, the Waters in those parts being swollen so high that they could not pass them; but that two Parties of Rascians sent out lately from *Caranzebet*, had brought back several Prisoners, and a good Booty. We hear from *Segedin*, that a Party of Hussars that were marched from *Chonaz* towards *Temeswaer*, had taken from the Enemy 13 Prisoners, and near 100 Horses. We have an account from *Moldavia*, that the Hospodar of that Province has received Orders from the Port to get together as many Forces as he can at *Jassy*, where a considerable number of Janizaries are to join him; it is not said on what design, but this and their other preparations in those parts might occasion a belief, that they intend to make use of the Advantage which the Divisions in *Poland* afford them, by attempting something on that side, were there not more reason to think that they will have work enough to defend themselves, and to give a stop to the further progress of the Imperial Armies this next Summer.

Strasbourg, May 7. Our Letters from *Strasbourg* of the 2d Instant say, the Duke of *Lorraine* was expected there the 6th, and that extraordinary Preparations were making for his Reception.

Hambourg, May 9. The Duke of *Wirtemberg* came hither the 29th past from *Copenhagen*, and intends to be suddenly going for *Saxony*, and thence to *Poland*, to command there the German Forces that are in that Kings Service. This City having of late been very much disturbed by some Differences that have happened between the Senate and Burghers, the Emperor has appointed Commissioners to enquire into those Disorders, which being looked upon by some as prejudicial to their Liberties, the Burghers intend to meet again in a few days to consider whether they shall submit to this Commission. Our last Letters from *Dantzick* say, the Kingdom of *Poland* continues still in great confusion, though the King, and those in his Interests, use their utmost endeavours to accommodate Matters, and especially to unite

the two Parties in *Lithuania*, whose Animofities againft each other feem greater at prefent than ever. They add, That the Elector of *Brandenburg* paffed through *Dantzick* the firft Inftant in his way to *Corningsberg*.

Liege, May 6. The States of this Diocefe will feparate to morrow, having refolved over and above the ufual Free Gift of 25000 Crowns, to give the Elector of *Cologne* 30000 Crowns, towards the repairing the Fortifications of *Dinant*, and providing Stores for the Magazines of that place, which we hear will be evacuated the 15th or 16th Inftant, and accordingly 200 of his Electoral Highneffes Forces lie ready to take poffeffion of the fame.

Paris, May 9. The Sieurs *Heemskirke* and *Odyke*, had on the 6th Inftant a private Audience of the King. The 7th the Count *de Monsferolle*, Envoy Extraordinary from the Elector of *Bavaria*, had his Audiences of Leave at this Court with the ufual Ceremonies. The Duke and Dutcheffs of *Orleans* are gone to their Houfe at *St. Clou*, where they intend to remain part of the Summer. We have Advice from *Lyon*, That the Prince of *Monaco* arrived there the 21th Inftant going for *Monaco*, and the Duke of *Sesto* for *Madrid*; and that the next day the Prince of *Vaudemont* came thither in his way to *Milan*, and was Complimented by the Magiftracy: And that the Regiments of Horfe of *Buffi* and *Broglio* were marched through that place for *Vienne* in *Dauphiné*, where they are to remain till further Orders.

Bruffels, May 11. On the firft Inftant was observed the ancient Custom of Shooting at the Bird, by a Company Inftituted for that purpofe; The Elector of *Bavaria* himfelf won the Prize, and afterwards Entertained thofe of the Company at Dinner, and caufed Money to be thrown among the ordinary fort of People. The next day the Magiftrates of this City attended his Electoral Highneff with a Prefent of Wine, and a Purfe of 25000 Florins, the ufual Gift to our Governors on fuch Occafions; and the like will be done by the other Cities of *Brabant*. The Elector of *Bavaria* is gone to *Marimont*, where he will remain till the Electoral Prince his Son, arrives from *Munich*, who is expected the 20th Inftant. *Monfieur Caftellan* is come hither from *Germany*, being to remain at this Court with the Character of Resident from the Emperor, and had laft week his firft Audience of the Elector. Our Letters from *Madrid* of the 25th of *April* advife us, that the King of *Spain's* Health continued to mend every day, and that his Catholick Majefty would go the next day with the Queen to *Toledo*, where they intended to ftay about 6 weeks: The Conde *de Monterey* was ftill under Confinement in his own Houfe.

Hague, May 13. N. S. The States of *Holland* and *Weftrifriesland* are ftill affembled, having now chiefly under their Confideration the Drawing up farther Inftitutions for the Dutch Commiffioners of Trade in *France*. They talk of borrowing a confiderable Sum of Money for the King of *Spain* upon his Revenues in *Brabant*, which is to be employed to furnifh the Places which *France* has reftored to that Crown according to the Treaty of Peace, with the neceffary Magazines of Arms, Ammunition, &c. The Baron *de Bofen* parted hence lately for *Poland*, and goes by the way of *Dresden*. *Monfieur de Bourgeois*, the French Ambaffador, goes to morrow for *Aix la Chapelle*, where he defigns to ftay 3 weeks.

We hear the Elector *Palatine* intends to leave that place to morrow, and return to *Dufeldorp*.

Dublin, April 27. The Lords-Justices have iffued a Proclamation for further Proroguing the Parliament of this Kingdom from the 10th day of *May* next, to the 7th of *June* enfuing.

Deale, May 6. His Majefties Ship the *Medway*-ward, and failed yefterday from the River. Laft Tuesday came into our Road the *Oxenford* from the *Streights*, and the *Elizabeth* from *Lifbon*, as did likewife this morning the *Unity*, Capt. *Harding* Commander, from the *Barbadoes*.

Whitehall, May 7. On Thursday laft his Excellency the Count *de Bonffe*, Ambaffador Extraordinary from the King of *Sueden*, had Audience of their Royal Highneffes the Princefs and Prince of *Denmark*, being conducted by Sir *Charles Costerell* Mafter of the Ceremonies in the ufual manner.
