First Portion-Six carriages at Seymour Street, West side of roadway, commencing immediately North of the entrance to Railway Clearing House, 123, Seymour Street, extending Northward, by kerb, as far as necessary for six carriages.

Front of vehicles toward the South.

Second Portion.—Twenty-seven carriages at Barnby Street, South side of roadway, commencing at a point fifteen feet West from stone sett crossing at junction with Seymour Street, extending Westward, by kerb, as far as Ampthill Square.

Front of vehicles toward the East.

Note.—No cab will be allowed to stand on this portion between 6 a.m. and 8.30 a.m.
