I, the undersigned, Commissioner of Police of the Metropolis, do hereby APPOINT Standings for Hackney Carriages at the following places, and do make the following Regulations with regard to the Boundaries for the same, viz.:—

APPOINTMENTS.

AT SEYMOUR STREET, BARNBY STREET, AMPTHILL SQUARE AND HARRINGTON SQUARE. One hundred and twenty-one Hackney Carriages:

First Portion.—Six cabs at Seymour Street, West side of roadway, commencing immediately North of the entrance to Railway Clearing House, 123, Seymour Street, extending Northward, by kerb, as far as necessary for six cabs.

Front of cabs toward the South.

Second Portion.—Twenty-seven cabs at Barnby Street, South side of roadway, commencing at a point fifteen feet West from stone sett crossing at junction with Seymour Street, extending Westward. by kerb, as far as Ampthill Square.

Front of cabs toward the East.

Note.—No cab will be allowed to stand on this portion between 6 a.m. and 8.30 a.m.

Third Portion.—Sixteen cabs at Ampthill Square, South side, commencing at a point opposite Barnby Street, extending Westward, by kerb, as far as necessary for sixteen cabs.
