**FOOT-AND-MOUTH DISEASE (REGULATION OF MOVEMENT) ORDER OF 1933 (No. 4).**

Reduces the Controlled Area to which the Foot-and-Mouth Disease (Regulation of Movement) Order of 1933, as amended by the Foot-and-Mouth Disease (Regulation of Movement) Orders of 1933 (Nos. 2 and 3), applies to the following Area:—

*In the county of Buckingham.*

The borough of Chepping Wycombe.

The petty sessional divisions of Wycombe and Marlow (except the parish of Hedsor).

*In the county of Oxford.*

The petty sessional division of Watlington (except the parish of Great Haseley) and the parish of Pishill with Stonor.

*In the county of Berks.*

The boroughs of Wallingford, Newbury, and Wokingham.

The petty sessional division of Moreton, and the parishes of Sunninghill, Sunningdale, Crowthorne, Sandhurst, Finchampstead, Barkham, Aldermaston, Padworth, Beenham, Bradfield, Basildon, Ashamstead, Streatley, Aldworth, Compton, Hampstead Norris, Chieveley, Yattendon, Frilsham, Stanford Dingley, Bucklebury and its detached part, Cold Ash, Shaw cum Donnington, Thatcham, Greenham, Midgham, Woolhampton and its detached part, Wasing, Brimpton, Sandleford, and so much of the parishes of Winkfield, Easthampstead and Wokingham Without as lies to the south of the railway which runs from Sunningdale via Wokingham to Reading.

*In the county of Southampton.*

The borough of Basingstoke.

So much of the petty sessional division of Odiham as lies to the north of the railway which runs from Woking to Basingstoke and the parishes of Newtown, Burghclere, Echchinswell and Sydmonton, Kingsclere, Baughurst, Tadley, Mortimer West End, Silchester, Pamber, Bramley, Stratfield Saye, Stratfield Turgis, Hartley Wespall, Sherborne St. John, Sherborne upon Loddon, Monk Sherborne, Wootton St. Lawrence, Oakley, Basing, Newnham, and Up Nately and Mapledurwell.

**THE WILTSHIRE AND DORSETSHIRE COUNTY COUNCILS.**

**ROAD TRAFFIC ACT, 1930.**

**WHEREAS** in pursuance of Section 46 (1) of the Road Traffic Act, 1930, the Wiltshire and Dorsetshire County Councils have made application to the Minister of Transport for an Order to be made by him, the effect of which is:—

To prohibit, subject to such exceptions or conditions as to occasional user or otherwise, as may be specified in the Order, the driving of heavy and light locomotives, motor tractors, heavy motor cars (as defined respectively by Section 2 of the Road Traffic Act, 1930) and motor cars with a seating
