to him by the River Kent Catchment Board, under Section 4 (1) (b) of the Act, making provision for the constitution of a drainage district to be known as the Winster Internal Drainage District and of a Drainage Board therefor, and for certain matters supplemental thereto.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant out of our Common Fund to the Incumbent for the time being of the benefice of Plymstock, in the County of Devon and in the Diocese of Exeter, and to his successors Incumbents of the same benefice, one yearly sum or stipend of forty-five pounds, such yearly sum or stipend to commence as from the first day of November, in the year One thousand nine hundred and thirty-two, and to be payable in four equal portions on the first day of February, the first day of May, the first day of August and the first day of November in each and every year. Provided always that the yearly sum or stipend hereby granted or any quarterly portion thereof shall be payable only upon production to us on or after each of the said quarterly days of payment of a certificate (in such form as may be required by us) under the hand of the Bishop of Exeter certifying that during the quarter then ended an Assistant Curate has been employed within the parish to serve the Conventional District of Elburton and that such Assistant Curate has been in receipt of a stipend after a rate of not less than One hundred and twenty pounds per annum. Provided also that the yearly sum or stipend so granted shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting such parish and benefice.
