PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.

ASHBURTON (DEVON) GAS.

(Application by the Devon Gas Association Limited for a Special Order under the Gas Undertakings Acts 1920 and 1929 with respect to the Urban District of Ashburton in the County of Devon.)

NOTICE is hereby given that the Devon Gas Association Limited (hereinafter called "the Company") whose registered office is at

Haven Road, St. Thomas, Exeter, intend to apply to the Board of Trade for a Special Order under the Gas Undertakings Acts 1920 and 1929 (hereinafter called "the Order") for all or some of the following (amongst other) purposes:—

1. To transfer to and vest in the Company the goodwill of the business of manufacturing and supplying gas of the Urban District Council of Ashburton and all property rights powers and privileges of the said Council in connection with their gas undertaking (hereinafter called "the Council" and "the undertaking" respectively) upon and subject to such terms and conditions and subject to such provisions with regard to the liabilities and obligations of the Council as have been agreed between the Company and the Council or as may be prescribed by the Order and to prescribe the date on which the said transfer and vesting shall take effect.

2. To sanction and confirm and give effect to an agreement entered into between the Council and the Company for the purchase by and transfer to the Company of the undertaking.

3. To make provision as to the application of money received by the Council by way of payment of the purchase price of the undertaking and to make all such other provisions as may be necessary or expedient for the purpose of enabling the said transfer and vesting to be carried into effect.

4. To empower the Company to carry on the undertaking and to supply gas within the Urban District of Ashburton in the County of Devon.

5. To increase the maximum price now authorised to be charged for gas within the said Urban District and to provide as to the charges to be made for prepayment meters, fittings and stoves and as to the calorific value of gas to be supplied.

6. To authorise the Company to maintain erect alter improve and renew gasworks and plant for the manufacture and storage of gas and to manufacture and store gas and work up and convert residual products upon the lands upon which the gasworks of the Council are situate, or to discontinue the use of such works and to deal in residual products.

7. To provide as to the keeping of separate accounts of the undertaking, the sums which may be credited to the capital account of the undertaking, and the remuneration to be received by the Company out of the profits of the undertaking.

8. To empower the Company to contract with any persons for the supply by one party to the other of gas in bulk and to authorise the Company to supply gas in bulk from other works belonging to them.

9. To confer powers on the Company to purchase material for the conversion of residual products and lands, to sell and lease lands and to make provision with respect to the laying of pipes in private streets and for ancillary purposes, the notice to be given to the Company by consumers before removing and when discontinuing the supply of gas, stand by supplies, the mode of cutting off supplies, the recovery of the cost of cutting off supplies, the expenses of reconnecting a discontinued supply, the entry into premises to which a supply of gas is laid on and into
