##### RATING AND VALUATION ACT, 1925.

##### PRODUCT OF RATES AND PRECEPTS RULES.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Health after the expiration of at least 40 days from this date, in exercise of the powers conferred upon him by the Rating and Valuation Act, 1925, to make regulations entitled the Rating and Valuation Act (Product of Rates and Precepts) Amendment Rules, 1933.

And that on account of urgency the Minister of Health under section 2 of the Rules Publication Act, 1893, has made regulations entitled

the Rating and Valuation Act (Product of Rates and Precepts) Amendment Rules, 1933, to come into force immediately as provisional regulations, to continue in force until regulations have been made in accordance with the provisions of section 1 of that Act.

#### WARWICK.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Warwick being the Urban Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Warwick Corporation Act, 1928, so as:—

(1) To extend until the second day of July 1938 the time allowed by Section 22 of the said local Act for the completion of the River Wall and Promenade works authorised by Section 19 of the Act. The works are more particularly described as follows:—

A river wall and embankment with promenade and carriageway situate on the right bank of the River Avon (partly on the foreshore and bed of the river) commencing at a point one hundred and thirty feet or thereabouts east of the north-east corner of the bridge carrying the Banbury Road over the River Avon (commonly known as "Castle Bridge") extending thence in an easterly direction along the bank of the river for a distance of one thousand three hundred and fifty feet or thereabouts and there terminating, together with the works incidental thereto:

(2) For the purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, in force in the said Borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application:
