(a) In earthen graves now existing in the said Churchyard, the burial may be allowed of the bodies of the following persons at their decease, viz., William John Austen, Elvey Pope, Fanny Anne Brooker, Anne Maria Culver, Lucy Clark, Edward Marsh, Mary Mills, Susan Margaret Raby and Frederick William Bird, subject in each case to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the

(b) In the said Churchyard in grave spaces in which no interment has heretofore taken place, the burial may be allowed of the bodies of Mary Pidduck Twyman and Mary Morgan at their decease, subject to the condition that no part of the coffin containing the body shall in either case be at a depth less than three feet below the level of the surface of the ground adjoining the grave.
