> BOROUGH OF EALING. Public Health Act, 1925.

BY an Order made under Section 77 of the Public Health Act, 1925, the Minister of Health has prescribed the rate of interest recoverable by the Council of the Borough of Ealing in respect of expenses for private street works at 4½ per cent. per annum or such less rate as the Council may from time to time determine, instead of 5 per cent. per annum.
