#### METROPOLITAN STAGE CARRIAGES.

The Secretary of State for the Home Department gives notice that he made on the 28th June, 1933, an Order under the Metropolitan Public Carriage Act, 1869 (S.R. & O., 1933, No. 635), revoking the provisions of the existing Orders under that Act which relate to mechanically propelled stage carriages. The revocations take effect as from the 1st July, 1933, except as regards the provisions relating to lost property which are revoked as from 1st October, 1933.

The licensing of public services vehicles, tramcars and trolley vehicles, and of their drivers and conductors, will from the 1st July, 1933, be carried out in accordance with the provisions of the London Passenger Transport Act, 1933.
