MINISTRY OF AGRICULTURE AND FISHERIES.

SUBJECT.

Authorises the landing at the Port of London of a black buck and a chinkara brought from India.

FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1933 (No. 62).

SUBJECT.

Declares the following area to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Area Restrictions) Order of 1925:—

An Area comprising:—
