CATERHAM AND WOLDINGHAM AND DISTRICT ELECTRICITY SPECIAL ORDER.

NOTICE is hereby given that the County of London Electric Supply Company Ltd. whose registered office is situate at County House, 46-47, New Broad Street, in the City of London (hereinafter called "the County Company") intend to apply to the Electricity Commissioners for a Special Order (hereinafter called "the Order") under the Electricity (Supply) Acts 1882 to 1928 for the following purposes (that is to say):—

To empower the Urban Electric Supply Company Ltd. whose registered office is situate at Broad Sanctuary Chambers in the City of Westminster to sell and the County Company to purchase the undertakings of the said Urban Electric Supply Company Ltd. authorised by the Caterham Electric Lighting Order 1900 and the Woldingham and District Electricity Special Order 1924 and to make such other provision as may be necessary or expedient in respect of the transfer of the said undertakings to the County Company.

And notice is hereby given that copies of the draft Order have been deposited for public inspection with the Clerk of the Peace for the County of Surrey at his office at Kingston-on-Thames, the Clerk to the Caterham and Warlingham Urban District Council at his office at Harestone Valley Road Caterham, the Clerk to the Coulsdon and Purley Urban District Council at the Council Offices, Purley, and the Clerk to the Godstone Rural District Council at his office at Station Road East, Oxted.

Every authority company body or person desirous of bringing before the Electricity Commissioners any objections respecting the application must do so by letter sent by registered post addressed to the Secretary, Elec-

tricity Commission, Savoy Court, Strand, London, W.C.2, and despatched on or before the 30th day of September, 1933, and a copy of such objections must at the same time be forwarded to the undermentioned Solicitor.

THE SOUTH ESSEX WATERWORKS ACT, 1928.

THE South Essex Waterworks Company (hereinafter called "the Company") pursuant to subsection (2) of Section 27 of the South Essex Waterworks Act, 1928, of which Section the marginal note is "obligation to supply water in bulk" hereby this 27th day of July, 1933, give notice to you the Essex County Council that the date when the Company anticipate that the second instalment works within the meaning of the said Act (which works are under that description defined by Section 3 of the said Act) will be brought into use is the 24th day of June, 1934.

Section 27 of the said Act provides (amongst other things) by subsection (2) thereof that within twenty-one days after the giving of this Notice the Company shall publish a copy of this Notice (in the said Section referred to as "the Second Construction Notice") once in each of two successive weeks in the London Gazette and in a newspaper published and circulating in the County of Essex and provides (by subsection (3) thereof) that subject to the provisions of the said section any of the authorities as in the said Section defined (that is to say the Corporation of every Borough and the Council for every Urban or Rural District in the Administrative County of Essex who are authorised to supply water) shall be entitled within six months after the date of the last publication under subsection (2) thereof of this Notice to serve on the Company
