

propose that from and after the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of All Saints, Child's Hill, Hendon, the said New Parish of Saint Peter, Cricklewood, and the said New Parish of Saint Michael, Golder's Green, shall be altered so that (first) all those portions of the said New Parish of All Saints, Child's Hill, Hendon, and of the said New Parish of Saint Michael, Golder's Green, which are described in the First Schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such New Parishes and shall be annexed to and shall in future form part of the said New Parish of Saint Peter, Cricklewood; (secondly) all those portions of the said New Parish of Saint Michael, Golder's Green, which are described in the Second Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured green shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of All Saints, Child's Hill, Hendon; and (thirdly) all those portions of the said New Parish of Saint Peter, Cricklewood, and of the said New Parish of All Saints, Child's Hill, Hendon, which are described in the Third Schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured purple shall be dissevered from such New Parishes and shall be annexed to and shall in future form part of the said New Parish of Saint Michael, Golder's Green.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULES to which the foregoing Scheme or Representation has reference.

*"The First Schedule.*

"The territory to be annexed to the New Parish of Saint Peter, Cricklewood, in the County of Middlesex and in the Diocese of London, comprising:—

"All those contiguous portions of the New Parish of All Saints, Child's Hill, Hendon, and of the New Parish of Saint Michael, Golder's Green, both in the said County and Diocese which, taken together, are bounded upon the south-west by the said New Parish of Saint Peter, Cricklewood, and upon the remaining sides, that is to say, upon the east and upon the north-west by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Peter, Cricklewood, from the said New Parish of All Saints, Child's Hill, Hendon, at the junction of Cricklewood Lane and Dersingham Road, and extending thence northward along the middle of Dersingham Road for a distance of 16 chains or thereabouts to its junction with

Purley Avenue, and extending thence first eastward and then northward along the middle of Purley Avenue for a distance of 13½ chains or thereabouts to its junction with the road called The Vale and extending thence eastward along the middle of The Vale for a distance of 2¼ chains or thereabouts to a point opposite to the middle of the footpath leading into Cheviot Gardens and extending thence north-westward to and along the middle of the said footpath for a distance of 4 chains or thereabouts to the point where it reaches the south-eastern side of Cheviot Gardens, and extending thence first north-westward to and then northward along the middle of Cheviot Gardens (thereby crossing the boundary which divides the said New Parish of All Saints, Child's Hill, Hendon, from the said New Parish of Saint Michael, Golder's Green) for a distance of 10 chains or thereabouts to its junction with Pennine Gardens, and extending thence south-westward along the middle of Pennine Gardens for a distance of 10½ chains or thereabouts to the boundary which divides the said New Parish of Saint Michael, Golder's Green, from the said New Parish of All Saints, Child's Hill, Hendon, and extending thence south-westward along such boundary for a distance of 4½ chains or thereabouts to the point where the boundaries of the said New Parish of Saint Michael, Golder's Green, of the said New Parish of All Saints, Child's Hill, Hendon, and of the said New Parish of Saint Peter, Cricklewood, all meet.

*"The Second Schedule.*

"The Territory to be dissevered from the said New Parish of Saint Michael, Golder's Green, and to be annexed to the said New Parish of All Saints, Child's Hill, Hendon, comprising:—

"I. All that portion of the said New Parish of Saint Michael, Golder's Green, which is bounded upon the south-east and upon the north-east by the said New Parish of All Saints, Child's Hill, Hendon, and upon the remaining side, that is to say, upon the north-west by an imaginary line commencing at the point where the boundary which divides the said New Parish of All Saints, Child's Hill, Hendon, from the said New Parish of Saint Michael, Golder's Green, crosses the middle of Armitage Road, and extending thence south-westward along the middle of Armitage Road for a distance of 19 chains or thereabouts to its junction with the road called Wayside, and extending thence south-eastward along the middle of Wayside for a distance of 1 chain or thereabouts to the boundary which divides the said New Parish of Saint Michael, Golder's Green, from the said New Parish of All Saints, Child's Hill, Hendon.

"II. And also all that other portion of the said New Parish of Saint Michael, Golder's Green, which is bounded upon the south-east by the said New Parish of All Saints, Child's Hill, Hendon, and upon the remaining sides, that is to say, upon the east, upon the north-west and upon the south-west by an imaginary line commencing upon the boundary which divides the said New Parish of All Saints, Child's Hill, Hendon, from the said New Parish of Saint Michael, Golder's Green, at the point where the northern boundary of the Basing Hill Recreation Ground reaches the
