

eastern side of Hendon Way, and extending thence first westward to and then northward along the middle of Hendon Way for a distance of 2 chains or thereabouts to its junction with Pennine Gardens, and extending thence south-westward along the middle of Pennine Gardens for a distance of 5 chains or thereabouts to its junction with Cheviot Gardens, and extending thence southward along the middle of Cheviot Gardens for a distance of 1½ chains or thereabouts to the boundary which divides the said New Parish of Saint Michael, Golder's Green, from the said New Parish of All Saints, Child's Hill, Hendon.

*"The Third Schedule.*

"The territory to be annexed to the said New Parish of Saint Michael, Golder's Green, comprising:—

"I. All that portion of the said New Parish of Saint Peter, Cricklewood, which is bounded upon the east and upon the north by the said New Parish of Saint Michael, Golder's Green, upon the west by the New Parish of Saint John, West Hendon, in the said County and Diocese, and upon the remaining side, that is to say, upon the south, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint John, West Hendon, from the said New Parish of Saint Michael, Golder's Green, at the point where such boundary diverges westward from following Claremont Road, and extending thence first southward to and then north-eastward along the fence separating Clitterhouse Recreation Ground from the houses and premises situate on the northern side of Quantock Gardens and of Cotswold Gardens for a distance in all of 15 chains or thereabouts to a point opposite to the middle of the roadway leading into Cotswold Gardens, and extending thence southward to and along the middle of such roadway for a distance of 2 chains or thereabouts to its junction with Cotswold Gardens and Purbeck Drive, and extending thence southward along the middle of Purbeck Drive for a distance of 6 chains or thereabouts to its junction with the northern branch of Pennine Gardens and extending thence southward in a straight line for a distance of 1½ chains or thereabouts to the point where the boundaries of the said New Parish of Saint Peter, Cricklewood, of the said New Parish of Saint Michael, Golder's Green, and of the said New Parish of All Saints, Child's Hill, Hendon, all meet.

"II. And also all that portion of the said New Parish of All Saints, Child's Hill, Hendon, which is bounded upon the south-west and upon the north-west by the said New Parish of Saint Michael, Golder's Green, upon the north-east by the District of Saint Alban, Golder's Green, in the said County and Diocese, and upon the remaining side, that is to say, upon the south-east, by an imaginary line commencing upon the boundary which divides the said District of Saint Alban, Golder's Green, from the said New Parish of All Saints, Child's Hill, Hendon, at the junction of the Ridgeway with Armitage Road, and extending thence south-westward along the middle of Armitage Road for a distance of 3 chains or thereabouts to the boundary which divides the said New Parish of All Saints,

Child's Hill, Hendon, from the said New Parish of Saint Michael, Golder's Green."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patron and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patron and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 13th day of July, 1933, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken out of the New Parish (sometime Consolidated Chapelry) of All Saints, Squirrel's Heath, in the County of Essex and in the Diocese of Chelmsford:

"Whereas we are satisfied that the said New Parish of All Saints, Squirrel's Heath, is a Cure wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular part of the said New Parish of All Saints, Squirrel's Heath, which is hereinafter mentioned and described should be constituted a separate District in the manner which is hereinafter set forth:
