trict any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £200 will, after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme, be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"Now, therefore, with the consent of the Right Reverend Henry, Bishop of Chelmsford (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all that part of the said New Parish of All Saints, Squirrel's Heath, which is described in the Schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be constituted a separate District for spiritual purposes and that the same shall be named 'The District of Saint Michael, Gidea Park':

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Michael, Gidea Park, being:-

"All that part of the New Parish (sometime Consolidated Chapelry) of All Saints, Squirrel's Heath, in the County of Essex in the Diocese of Chelmsford, which is bounded upon the west and upon the north by the Parish of Romford, in the said County and Diocese, and upon the remaining sides, that is to say, upon the east and upon the south east, by an imaginary line commencing upon the boundary which divides the said Parish of Romford from the said New Parish of All Saints, Squirrel's Heath, at the junction of Eastern Avenue with the Chelmsford Road, and extending thence south westward along the middle of the last-mentioned road for a distance of 12 chains or thereabouts to its junction with Upper Brentwood Road and extending thence first south eastward and then southward along the middle of Upper Brentwood Road for a distance of 471 chains or thereabouts to the centre of the bridge which carries it across the Main line of the Great Eastern Section of the London and North Eastern Railway, and extending thence south westward along the middle of such line of

railway for a distance of 66 chains or thereabouts to the point where the boundaries of the said New Parish of All Saints, Squirrel's Heath, of the said Parish of Romford, and of the New Parish of Saint Andrew, Romford, in the said County and Diocese, all meet."

And whereas drafts of the said Scheme have,

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly herein-before mentioned Act, been transmitted to the Patron and to the Incumbent of the New Parish of All Saints, Squirrel's Heath, out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patron and Incumbent have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Chelmsford.

HEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, duly prepared, and laid before His Majesty in Council, a Scheme hearing date the 27th day of July, 1933, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and of the Act of the 19th and 20th years of Her said late Majesty, Chapter 104, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the new Parish (sometime Particular District) of Wadsley, partly out of the New Parish (sometime Chapelry District) of Stannington, partly out of the New Parish (sometime District Chapelry) of Saint Mary, Walkley, and partly out of the New Parish (sometime District Chapelry) of Saint John the Baptist, Owlerton, all in the County of York and in the Diocese of Sheffield:

"Whereas we are satisfied that the said New Parish of Wadsley, the said New Parish of
