WHEREAS the Minister of Health, after giving 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to His Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Kennington, in the County of Kent, save with the previous approval of the Minister of Health, should be prohibited, and that burials should be discontinued therein as hereinafter directed:

And whereas by an Order in Council of the 26th June, 1933, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 8th day of August next, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act:

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to order, as it is hereby ordered, that no new burial ground shall be opened in the said Civil Parish of Kennington save with the previous approval of the Minister of Health, and that burials shall be discontinued therein as follows, viz. :—

KENNINGTON.—Forthwith and entirely in the Parish Church of Saint Mary, in the said Parish, and in the Churchyard attached thereto.

Provided that—

In the walled grave now existing in the said Churchyard and belonging or reputed to belong to the Allchin family, the burial may be allowed of the body of Mrs. Avice Allchin at her decease subject to the condition that the coffin buried in such grave be separately enclosed by stonework or brickwork properly cemented.
