##### SUBJECT.

*Release of the Leicester Foot-and-Mouth Disease Infected Area from Restrictions.*

#### FOOT-AND-MOUTH DISEASE (INFECTED AREAS) ORDER OF 1933 (No. 66).

##### SUBJECT.

Declares the following to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925:—

An Area comprising:—

*In the county of Norfolk.*

The city and county borough of Norwich and the county borough of Great Yarmouth.

The petty sessional divisions of Tunstead and Happing, East and West Flegg including its detached part, Blofield and Walsham including its detached part, Taverham, South Erpingham, and North Erpingham (*except the parishes of Runton, Beeston Regis, Sheringham, Upper Sheringham, East Beckham, West Beckham, Aylmerton, Gresham, and North Barningham*).
