BIRKENHEAD ELECTRICITY (EXTENSION).

NOTICE is hereby given that the Mayor, Aldermen and Burgesses of the County Borough of Birkenhead (hereinafter referred to as "the Corporation") whose address is Town Hall, Birkenhead, have applied to the Electricity Commissioners under the Electricity (Supply) Acts 1882 to 1928, for a Special Order (hereinafter referred to as "the Order") for all or some of the following purposes (that is to say):—

1. To extend the area for the supply of electrical energy by the Corporation so as to enable them to provide and distribute electrical energy for all public and private purposes as defined by the Electricity (Supply) Acts 1882 to 1928, within the following areas (which have already been equipped for the purpose by the Corporation on behalf of the Wirral Rural District Council) namely:—(i) the urban district of Wirral, (ii) the urban district of Neston, (iii) so much of the urban district of Bebington as prior to the coming into operation of the County of Chester

Review Order 1933 formed (1) the parish of Storeton and part of the parishes of Brimstage, Eastham, Childer Thornton, Hooton, Raby, Thornton Hough and Willaston in the rural district of Wirral, (2) part of the urban district of Neston and Parkgate and (3) the parish of Poulton-cum-Spital in the said rural district, except the portion following, that is to say, the portion bounded by an imaginary line commencing at a point where the bridge over the joint railways of the London Midland and Scottish and the Great Western Railway Companies crosses the parish boundary three hundred and forty feet or thereabouts north of Spital Station thence proceeding in a south-westerly and southerly direction along the occupation road leading from the said bridge to the main road from Spital Station to Gayton thence proceeding in a westerly direction along the said main road from Spital Station to Gayton for a distance of nine hundred and seventy feet or thereabouts to the footpath running in a north-westerly direction to the Birkenhead—Neston main road thence proceeding along the said footpath to the northern boundary of the said parish thence proceeding in an easterly and southerly direction along the boundary of the said parish to the point of commencement, (iv) so much of the urban district of Ellesmere Port as prior to the coming into operation of the County of Chester Review Order 1933 formed the parish of Great Sutton and part of the parishes of Hooton, Childer Thornton, Eastham, Willaston and Little Sutton in the rural district of Wirral, and (v) so much of the rural district of Chester as prior to the coming into operation of the County of Chester Review Order 1933 formed the parish of Ledsham and part of the parishes of Little Sutton, Willaston, Puddington and Burton in the rural district of Wirral all in the County Palatine of Chester (hereinafter referred to as "the added area").

2. To authorise the Corporation to exercise within the added area all powers usually conferred upon distributors of electrical energy.

3. To authorise the Corporation to break up streets and parts of streets not repairable by the local authority and railways within the added area.

4. To make provision as to the maximum prices which may be charged by the Corporation for electricity within the added area.

5. To authorise the Corporation to break up Arrowbrook Lane in the urban district of Hoylake which is outside the added area.

6. To apply to the added area with or without modification all or some of the provisions of the Birkenhead Electricity Orders 1890 to 1925, the Birkenhead Extension Act 1927, the Birkenhead Corporation Act 1930 and the Birkenhead Corporation Act 1932.

7. To amend, alter, repeal or revoke the Wirral and Neston Electricity Special Order 1925 or so much thereof as relates to the added area and to vary and extinguish all rights and privileges which would interfere with the objects of the intended Order and to confer other powers and privileges.

And notice is hereby also given that any authority, company, body or person desirous of bringing before the Electricity Commissioners any objections respecting the application must do so by registered letter addressed
