MERCHANDISE MARKS ACT, 1926.

REPORT OF THE STANDING COMMITTEE.

With reference to the notice which was published in the London, Edinburgh and Belfast Gazettes of the 21st April, 1933, regarding a

reference made by the Board of Trade to the Standing Committee under the Merchandise Marks Act, 1926, in respect of the following classes and descriptions of imported goods:—

- (1) Clocks, including mechanically driven, electrically driven (from mains and batteries), electro-magnetically driven, electrically wound, boudoir and travelling clocks;
- (2) Clock movements of all descriptions with or without escapements;
- (3) Synchronous electric motors of the type used for clocks, clock movements, or time recording instruments;
- (4) Platform escapements;
- (5) Clockwork movements for apparatus or instruments other than apparatus or instruments used for indicating the time of day;
