

## LOCAL GOVERNMENT ACT, 1888.

## ADMINISTRATIVE COUNTIES OF THE PARTS OF HOLLAND AND THE PARTS OF KESTEVEN.

Whereas in pursuance of Section 54 of the Local Government Act, 1888, a representation has been made to the Minister of Health by the Council of the Administrative County of the Parts of Holland, that it is desirable that the common boundary between the Administrative Counties of the Parts of Holland and the Parts of Kesteven, should be altered by a Provisional Order under the Act, so as to include therein parts of the Rural Parishes indicated in the Schedule below:
